




# Average High Court Hours




#### High Court: Conviction Rates



# High Court: Average Finalisation Rate




# \*High Court: Average New Cases per month





#### Lower Courts: Average Hours




# Lower Courts: Average Finalisation Rates pm



# PRESENTATION OF TARGETS AS SUBMITTED FOR ENE AND PROPOSED NEW PRIORITIES 2006/2007 (NEW FINANCIAL YEAR)

- The NPS requested an allocation of funds for the following priorities:
  - The increase of 890 prosecutor posts over the next three years to reach the ratio of two prosecutors per court. A substantial amount has, in principle, been awarded for the appointment of additional prosecutors.
  - To appoint more managers in line with the increase of the proposed prosecutors.
  - Expansion of the Aspirant Prosecutors Program from fifteen to seventeen centres.
  - Formalise and expand the Court Preparation Program to at least two court preparation officials per dedicated sexual offences court.

# Continued

- There are currently sixty six Court preparation officials providing support to abused children in preparing them for the court proceedings. A total number of 50 000 victims have to date been prepared by the said officials.
- Establish a core of prosecutors to deal with organized crime matters.
- Establish a core of prosecutors to follow a community orientated approach in prosecutions.
