#### INTRODUCTION

## The People's Housing Partnership Trust was established in 1997 with the aim:

 To create a critical mass of support for and promote public awareness of the People's Housing Process by establishing a viable and sustainable framework of support to the People's Housing Process at all levels



#### MANDATE

 To capacitate and engage with national, provincial, local governments and civil society to meaningfully participate and support the People's Housing Process.



#### **OBJECTIVE**

 The direct objective of PHP is to increase beneficiary participation so that communities are able to deliver housing for themselves and by so doing, citizenship is improved and individuals and communities empowered.

#### Objective:

 To establish and manage a support programme that provides technical advisory services to existing and potential support providers, support organisations, provincial and local government and communities.

#### RESEARCH AND DEVELOPMENT

#### Objective:

 To develop a bank of information, documentation and tools on the PHP accessible to the government, support organisations and communities.
