Challenges within Federations

- Lack of adequate funding
- Lack of administrative capacity within National Federations
- Lack of qualified coaches across the spectrum of sport in South Africa
- The removal of Administration Grants by Sport and Recreation South Africa
- Inconsistency in relation to Lottery funding no distribution agency no allocation
- This results in resources lying in limbo to the detriment of Athletes
- Dwindling women participation due to lack of interest/lack of opportunities
- All of these factors is serving to hamper transformation in sport

Athletes Commission

- Athletes Commission has been constituted in SASCOC
 - The Chair Donovan Cech is a member of the Board of SASCOC
 - They also have two delegates at the General Assembly of SASOC
 - Their task is to be the voice of Athletes concerns

Medical and Scientific Commission

- Medical and Scientific Commission has been constituted in SASCOC
 - To interface with the Athletes Commission to determine Athletes requirements
 - To develop testing protocols and determine the relevance of these protocols
 - To revamp the Medical team selection policy

Anti Doping Commission

- Anti Doping Commission has been constituted in SASCOC
 - To educate Athletes and Officials on Anti-Doping
 - To partner with SAIDS and work with coaches and athletes
 - To finalise the Anti-Doping policy of SASCOC

Coaches Commission

- Coaches Commission has been constituted in SASCOC
 - To evaluate coaching manuals in various National Federation's
 - To liaise with federations to determine THETA accreditation
 - To investigate the legalities of licensing coaches
 - To accredit SA coaches with International Organisations
 - To keep in step with world trends



National Colours

- The National Colours Regulations was updated and reviewed by the National Colours Commission
- The updated rules and regulations were circulated to all SASCOC members for input during the month of June 2006
- We are continuing with the awarding of National Colours based on the existing regulations



Update on Dispute's

- SASCOC met with Martial Arts Authority of South Africa, South African WUSHU Federation and Karate South Africa
 - It was agreed that no overlapping membership will be permitted
 - Martial Arts Authority of South Africa will change its name to Martial Arts South Africa
- Karate in South Africa
 - The officially accepted structure is called Karate South Africa
 - The President is Mr. Cass Sehlolo and the Secretary is Mr. Leon Beech
 - Karate Association of South Africa still has to be dissolved as per a constitutional process
 - Mr. Sam Ramsamy is presently addressing this on behalf of SASCOC



Operational Requirement Restructuring

Given SASCOC's mandate, the Board appointed a CEO in April 2005 who had the operational responsibility for management and delivery of the MTT objectives.

- The Board of SASCOC also understood from several consultations with the Ministry that set up costs for SASCOC would be secured.
- Unfortunately, that funding did not materialise.
- As the financial year unfolded, it became clear that our resources were depleting without commensurate revenue generation.
- We have embarked on a consultative process with our staff to right size the organisation to meet operational requirements based on economic reasons.
- This process has taken 4 months to formulate the new structure to meet budgetary and operation requirements
 - 6 retrenched
 - 4 resigned



Sponsorship

In 2005 we appointed Grinaker Sponsorship Marketing Agency

- The board reviewed this contract and decided to appoint Sail Sponsorship Marketing Agency in 2006
- Sail Commenced with:
 - Comprehensive brand building exercise.
 - Audit of the current position The board reviewed this contract and decided appoint Sail as our sponsorship marketing
 - In 2006 appointed Sail as SASCOC Sponsorship Agency.
 - A survey of the brands and brand values of the various organisations under the SASCOC umbrella.
 - The findings revealed that, at this stage, the Olympic rings is the only marketable brand, on any significant scale.
 - The next stage is to repackage SASCOC as a brand, and re-evaluate our value proposition to develop a viable offering for our sponsors and funders, without whom we cannot survive.
