1. Terms of reference

The Second 2010 FIFA World Cup South Africa Special Measures Bill [B16/2006] has been referred to the Portfolio Committee on Sport, Recreation, Arts and Culture by the NCOP Business Committee for consideration.

2. Consultation

The Committee conducted public hearings within the province to ascertain public inputs.

3. Report on inter-provincial negotiations

The Special Delegate, Hon, L Suka who attended inter-provincial negotiations reported that a concern raised by the Eastern Cape Province was addressed.

4. Resolution

- (2) Hon. L Suka be designated as a special delegate to represent the Province of the Eastern Cape at the final mandate meeting on Wednesday, 23 August 2006 in Cape Town.
