Dear Mr. Arico Kotze,

Thank you for the opportunity to address some concerns about the Civil Union Bill, and about legislative and parliamentary processes via your office to the National Council of Provinces Committee.

I object to any recognition of "marital" unions other than between one man and one woman – because the Almighty God who created the universe, and who created man and woman in His image, does not condone anything else than the "becoming of one flesh" between one man and one woman.

I object to the influence and example that such a Bill has on society at large, and towards setting "norms" for future generations. One man, married to one woman, is the basic unity which bring forth offspring, which nurture the family, which sets examples, and which form the basic building block of home, family, church, and society.

God forbids any sexual liaison outside of marriage, and between anything but *man and woman* lawfully married.

Without society's compliance with the law stated in the Holy Bible (in e.g. Deuteronomy 5, 27 and 28), we are drifting around aimlessly and try to make our own laws, satisfy our hedonistic desires, serve the flesh in self gratification, become a law upon our fickle selves, and become a society of situation ethics, immorality, sin and moral decay, - never mind actually even considering to give legal status to persons and situations of pervasive nature through spending parliaments time on designing and voting on such a bill as the Civil Union Bill.

Are sexual perverts, immoral people and homo sexuals of some notable future economic, societal, and governmental significance, - that the rest of society should be subject to laws protecting their minority interests at the cost of general moral fibre, example to future generations, and upholding God's law?

Furthermore, I am perturbed by reports from within government/ parliament, - that members elected as representatives of the people/ constituencies, are encouraged to vote according to prescription, instead of according to their better judgement and consciouns. Let me be blunt;- such conduct has no place in a civilised, ethical, and God-fearing democracy.

Like the case of the legalising of abortion in South Africa (which authorises the legalised *murder* of unborn babies – whilst murderers and hardened criminals are not punished by death as God had ordered the state to do in it's duty as *responsible* government towards it's citizens), South Africa's eagerness to become a "world trendsetter", - by means of rigged legislative processes and "leading innovatively", - seem to manifest great confusion, the absence of accountability, lack of ethical standards, and lack of Godly principles.

In concluding summary;- my vote is firstly strictly against the legalisation of any "marital" union other than marriage between one man and one woman as described in the Holy Bible (based on religious and social considerations), and secondly against any parliamentary or legislative process which does not consider the public opinion, and does not allow free, fair and ethical procedures.

Thank you for your facilitating of this matter - which I consider of utmost importance to (South African, - if not international) society at large, and certainly so before YahWeH, the God Almighty.

Ref: Submission on the Civil Union Bill
How the Legislation will impact on the community.

The Civil Union Bill will have devastating effects on society in general in that it justifies and promotes immorality and legalises perversion. It approves of 'gay unions' as an alternative legitimate lifestyle and thereby devalues traditional MARRIAGE and despoils sound family life.

The purpose of 'gay marriage' is obviously to reduce the population of South Africa, in the same way as 'abortion on demand' is designed to keep babies from being born. These two anti-nature, anti-family and anti-God policies clearly come from anti-African powers outside the country, for the South African population has shown that it overwhelmingly rejects them. For instance, the Human Sciences Research Council (HSRC) found that 80% of all South Africans oppose same sex marriage. Further, the Christian Churches voted against 'gay marriage' by forming a 20-million members strong 'Marriage Alliance' to defend traditional marriage. Tens of thousands of people participated in marriage marches. Unnumbered submissions have been made to Parliament. The African Christian Democratic Party (ACDP) proposed to amend the constitution to define "marriage as a voluntary union of a man and a woman." All these endeavours have expressed 'the will of the people' in no uncertain terms, and in a 'Democracy' the 'will of the people' is supposed to be paramount.

The legalisation of 'homosexual marriage' will destroy our youth through ungodliness, immorality, sickness and drugs. It will increase crime, litigation, and relationship troubles. It will expose all boys to possible pedophile exploitation. It will put pressure on the government to liberalise the law until sin triumphs and marriage becomes utterly valueless. 
