I wish to protest in the strongest terms against this Civil Union Bill. The ANC is using their majority in Parliament to railroad this Bill despite the fact that most South Africans do not agree with it.

Should this Bill go through, we will be giving special status in our national consciousness to "families" that deny children either a mother or a father. Dear Mr Kotze,

I would like voice my very vigorous and impassioned protest at the passage of the Civil Unions Bill which seeks to legitimize same-sex unions as marriage. Why should these people want to get married?
