## Plant Health & Inspection Services



- Inspections were done on liquor products, plant and plant products, plant propagating material, GMO's, animal and animal products which includes enhancement of quality assurance and phytosanitary and zoosanitary risk management.
- Standard operating procedures have been drafted in order to harmonize technical operations nationally
- A 3 month international training course was given to beagle dogs and their handlers. These dogs have been trained to detect illegal agricultural products brought into South Africa via the luggage of international travelers

## Risk and Disaster Management

- Early warning systems were established and early warning information provided
- Advisories were issued on a regular basis
- Workshops and awareness campaigns were organised country wide
- Drought relief scheme was implemented
- Assessments of drought situation was undertaken and information utilised to forecast adverse situation's country wide
- Implementation of the cold spell relief and flood relief



## Food Safety and Quality Assurance

- Compilation of a compendium of maximum residue levels for pineapples
- Groundnut and potato export standards as well as requirements were gazetted and completed respectively
- Amendments for export standards for frozen fruits and vegetables as well as red meat regulations were concluded
- Animal feeds policy, Pesticide Management policy and stock remedies policy, were published for public comment whereas the policy on Fertilizers and Agricultural remedies policy had only be commented on internally



- Training of animal owners in is and marking of animals took place
- Compilation of new regulations for keeping of ostriches as well as a protocol on bio security on ostriches
- Classical Swine Fever control in the Eastern Cape Province was a major challenge throughout the year
- An Outbreak of Foot and Mouth disease in Punda Maria, Limpopo was quickly brought under control

## Challenges



- Acquisition and retention of suitable skills for the various directorates within the programme
- With regard to Veterinary services, communication with provinces to implement programmes remains a special challenge
- Occurrence of certain diseases including the highly fatal Rabies in certain provinces
- Bio-security concerns as a result of exposure from imports
