Re: Letter received from Mrs J J C Thompson (nee Coetzee)


I refer to the attached correspondence received from a member of the public, Mrs Jennifer J C Thompson (nee Coetzee).

The content of the correspondence appears to focus on Mrs Thompson's concerns in regard to the following:

- **The existence of toxic waste must be reduced.**
She claims that those that defy the safety measures must be considered to be committing culpable homicide, treason, genocide and having a premeditated intention to murder.
- **Irresponsible termination of services of an Inspector Olivier (VIP Protection Services Rondebosch)**
She claims that he was one of the stalwarts that had curtailed terrorism and his dismissal correlated with an increase in terrorism in South Africa.
- **Diverse forms of genocide intended by the Concentration Torture System.**
She claims that she had been tortured/ persecuted at Stellenbosch University since mid 2000. She claims that the terrorists be exposed as they had infiltrated her life.

I have referred the correspondence to the Committee on Petitions and Members' Legislative Proposals for consideration. The content of the correspondence seems to indicate a lack of coherence on the part of Mrs Thompson. I would therefore advise that the Committee invite a specialist who would assist it with giving an assessment of the reasons for the incoherence.

Re: a) The existence of toxic waste must be reduced in humans and other existing non-human sources. Failure on the part of those who insist on defying the obvious measures of safety, preservation, protection of and within the nation, our nation, must be considered to be culpable of homicide, intentionally criminal, premeditated intentions to commit murder, treason, genocide, sabotage State RSA. b) Irresponsible Termination of the services of Inspector Olivier VIP Protection Services Rondebosch.

c) The diverse forms of genocide intended by the Concentration Torture System appears to be continuing unabated.

d) I informed my husband Kevin Thompson of the fact that I was being tortured/persecuted at Stellenbosch University since mid 2000ff I informed my biological brother Aubrey Coetzee about the fact that I was being tortured/persecuted in 2001 My husband knew that I did so then at the time. In order that my outrage at the blatant disregard of and for the sanctity of my life by 'millions' of men, their wives and in instances their children, be known in South Africa and abroad, towards the end of 2004 I enquired advice from a chief prosecutor at Stellenbosch magistrate court on legal proceedings to sue the Constitution RSA, Honourable President Thabo Mbeki, Kevin Thompson and Aubrey Coetzee for grossly deserting me, thereby making my life (authentic and the terrorist ploys and strategies of slanderously attributed wretchedness, filth, deceit and lies from within Church and State RSA), viable to onslaught from the terrorists, thereby grossly jeopardizing my life. She claimed that no legal process exists for those purposes. She prayed with me. All of these conversations mid 2000ff were private searches for assistance, I had not until today discussed any of this with any human beings. Neither have I written any of these details to any since mid 2000ff. Much of these lawful processes as enquiries exist. It is then that I detected what I claim with authority that the Law knew and knows the terrorists. Similar to amnesty, the law appears to be suspect of having subjected itself wrecklessly to violation, defiance and ridicule by lawlessness. It is no wonder that many in RSA and abroad still mock RSA. Law and governance RSA and the Constitution RSA by terrorism and lawlessness. The law has failed itself as it has repeatedly with crime. Perpetrators have always been favoured in RSA by a law that by its decision and enforced verdict(s) with respect to lawlessness, defines itself incapacitated by lawlessness. It is a disgrace that causes me to suffer at the hands of terrorism until today.

e) It is my opinion that Honourable President Thabo Mbeki, having been a surveillance specialist on covert and subversive activity RSA and abroad for most of his history, militant trained as are other Presidents before him, secretary ANC, Deputy President to ex President Nelson Mandela must have known of the terrorism prior to mid 2000. To declare that he was unaware is to imply that South Africa experiencing terrorism as rife as coups, continuous threats to security and rule, genocide, hatred must live the consequences of its ignorances as its just deserves. My reasoning fails in that I am not supposed to suffer. I am not a terrorist. I have lived within the Law of State RSA throughout my life, with no convictions or pending crimes against me. To claim as well that Honourable President Mbeki knew of the terrorism and did not respond would be disastrous and fatal for his awareness in reason that he would have by assumption willfully, deliberately failed RSA given the fact that genocide was not and is not being averted, terrorism reigns beyond just lawful living. I pray

to Almighty God that Honourable President Thabo Mbeki knows how to respond today. The worst classification for and of a nation that has defied innocence and intelligence by wretched beguile and hatred is that RSA can today be called a Despotic Dictatorship not unlike Cuba, Arabia, Israel, Palestine, Russia, Britain, Lybia, Germany, Korea, China, Japan, Turkey and dictator southern states of USA among others. As definition therefore a Pan African Democracy with not be, neither would a Democratic one world order. I suppose that we should all agree that Greenland independent of British rule can rule the world. At least when they say that it is cold, it is. They dress warmly and look protected against the elements and none are harmed except that nature takes its course.

f) I want the terrorists to be exposed as I have stated clearly over all of these years. To that effect, I have once again contacted Hayden at the American Embassy (I requested that Hayden in discussion with the Presidency RSA, set protective systems in place to protect the Presidency, RSA State and Church in 2006ff) The terrorists within the Concentration Torture System and without I presume utilized these suggestions and systems implemented to increase their torture, genocide on and into my life. I have requested that Hayden destroy all the systems he had devised. I expect him to contact me. I also contacted Interpol (France headquarters) again, and requested that the terrorists be exposed, convicted and incarcerated. I do not care for any criticism or ridicule in this. It is not my fault that I do not have the leadership role or designation to have facilitated these processes that I know would work under an official title or in an official capacity. I continue though to do as I know that I must in order to avert what could eventually be a civil revolution within RSA because of a vying for power in the form of Greek or Roman overthrowing by prowess and heroics as hero's regimes as displaced for change. It appears that the South African context will lend itself to a reasoning by men, that men and women revolt as Blacks as African retain power, Whites regain power. Coloureds usurp or gain power for not having had power of supreme rule before. Indians considered politically beloved Gandhi passivist self inflicted denial as preminent rule, and foreigners not considered that the forty years of apartheid and its intentional accruing of wealth by Whites then implies the Accruing of wealth now by Blacks with no due consideration of any other cultures or groups except that this must be logical reasoning. It is inevitable that a civil war threatens. In this I defy its arrogance in that I subvert it. Terror and Terrorism along with the terrorists must die by the hand of the Law and Lawful intervention in South Africa now. I say so. Terrorism is not innocent dallying with the odds, or usual politicking. It is vicious hatred. I refuse to coexist with terrorists, criminals and hatred. The only criminals (prior mid 2000ff and other hateful family members(my paternal and maternal family) since mid 2000ff I have ever had to tolerate fortunately before mid 2000 with unconditional love, in my family history :My Mom and Dad were Law abiding citizens throughout their lives : my maternal brothers' children and brothers) are juvenile delinquents as neighbourhood burglars, juvenile drug dependents , juvenile and adult alcohol dependents and possibly political criminals. My paternal history political and possibly adult alcohol dependents) I have always been law abiding. My parents taught me to be. I will not and do not accept responsibility for the misdeeds of others. I am not obligated to. Their (my family) deserting me since mid 2000ff suited the terrorists in that I presume that they used my family to serve them by various ploys from within Church and State RSA and abroad. I have passivist resentment of the clearest selective avoidance and distancing as form and type, against all who have detrimented me since mid 2000ff. I will not award their hatred. They will not and cannot regain their honourable and privileged statuses in my life ever again. If the relationships wane of own accord that is meant to be, given their duration of between 10 and 40 years. I do not plan to work at those useless relationships at all. It is not necessary. I have wasted my time with all of them. There are others who are more worthy of my holy love. I have found some and will continue to do so. In the meantime I continue to establish other holy relationships. I will not be a fool to allow myself to be vulnerable to their gross hatred and abuse without ensuring that they understand that they deserve to be punished rather than the present reality that the terrorists by my assumption, reward them for their hatred as they have hated me since? mid2000ff. One single day of their hatred directed at me was too many a day by, in and as it was: it's magnitude. I am hoping that they would have the decency to admit that they have been hateful and wretched. I am hoping that they would develop consciences and in the case of my brother Aubrey Coetzee not expecting his inheritance given his dishonoring our parents by this terrorist intent, since ?2001 or prior, and for grossly deserting me. The same applies to my husband then until August 2006. My parents in appointing me executrix of their estate, did not expect that I, their heiress as their daughter would be divorced. Aubrey is the other heir. Neither did my parents expect that Aubrey and Kevin would

grossly desert me when I needed them most as I fought for my life passively against the onslaught by terrorists who attacked by distortion and hatred, my family history in onslaughts against my parents and their person, achievements, my history, and even Aubrey's and Kevin's histories that they failed to defend as I defended all since mid 2000ff They can live with themselves, I do not have to. I will continue to pretend and wait for their retreat from my company. Had my parents been alive. Aubrey and Kevin would not have been able to feign my parents rejection of them for their gross desertion and cowardice. In honour of my parents will, even though unbeknown to them then, the outcome thus far of our relationships (Kevin's, mine and Aubrey's) I will let them have their inheritance by birth for Aubrey and Kevin by marriage and pursue the arduous course of legal battle whenever prudent and appropriate. I will teach them by legal means, the honour of honour without incurring any detriment to my parents' name(s) or possessions or aspirations or my own. The alternative is that I would have the honoured possession of all of my parents' assets because I can have that if I dispossess them, because I can. I will not. I expect that they admit to their hatred and that they are undeserving of such wonderful honours bestowed upon them by my beloved parents. I can fight the battle by legal means for honour that is , my parents', mine, for my parents and myself as long as I live. My heiress(es) and heir(s) by adoption and future marriage, will inherit my assets in the future. I am gentry (Coetzee and Snyman: RSA). This is my role. I am prepared.

a) The existence of toxic waste must be reduced in humans and other existing non-human sources. Failure on the part of those who insist on defying the obvious measures of safety, preservation, protection of and within the nation, our nation, must be considered to be culpable of homicide, intentionally criminal, premeditated intentions to commit murder, treason, genocide, sabotage State RSA.

b) **Irresponsible Termination of the services of Inspector Olivier VIP Protection Services Rondebosch.** In 2004 I met Inspector Olivier and Sergeant Titus by way of the appropriate referral of the staff at VIP Protection Services after discussing with them the urgencies and concerns that I had. On speaking to me. I gathered that Inspector Olivier was the specialist required to meet the interventive processes as necessary by my assumption an extremely precarious situation. Inspector Olivier, a white Afrikaner, an invaluable asset in this (ANC alliances etc) who by his accounts, had been serving South Africa for ten years or more by then, and that he had extensive experience at confronting apartheid terrorists and devising means by which to defy terrorism in the apartheid era and into the new dispensation. I would imply by this that he appears to have been one of the stalwarths who have curtailed terrorism so that we the citizens in South Africa could be safe. It concurs therefore that his dismissal correlates to an increased terrorism in South Africa. The terrorists were and are more than likely aware of the fact that a major obstacle to their terror and terrorism has been deposed, and we the public are unsafe. In this, State proffering terrorism and its whims, treason has been committed by State and Church South Africa. The Constitution would not succeed in presenting an alternative perspective in validation or verification.

c) **The diverse forms of genocide intended by the Concentration Torture System** appears to be continuing unabated. I have once again retraced my steps towards understanding the developments of the Constitution in addressing this torture in that it must speak to me in person. It has not thus far. None have discussed any circumstances of intervention with me in either Church or State, mid2000ff. I would not refrain from indicating that at present this in addition to other definitions if South Africa's identity defines South Africa other than a democracy. It is undoubtedly bound to adhere to a classification that can be applied appropriately as a despotic dictatorship, Church and State RSA. State and Church can still redefine

itself differently, but that the Constitution failed me dismally by not protecting me, not did it stop the torture. On the contrary, both Church and State have resorted to subversive and other processes of utilizing the systems of protection that I requested from the Constitution to torture, degrade, humiliate and demean me. That is treason. Treason will not be condoned by me in South Africa. The terrorists are still out there. They must be humiliated publicly and incarcerated for life until such time that the death penalty can execute them. Their deception is obvious, Their strategies degrade the intellect of those, by my assumption fools, who adhere to their methods and perceptions I am a genius. If I were an attorney they would have been incarcerated. They can beguile and lie to others, they cannot to me. It is this that none (family, friends, mentors, acquaintances) prefer to support me in person, their being defined by me as the terror enforcers, who were exposed to my protests in personal or individual discussions, mid 2000ff and others some of whom or all, intertwined with the obvious existing terrorists and their networks, who continue to practice genocide, would continue to be lawless at their peril. Their being implicated and participant is clear. None who prefer the conventional rightful law as government would condone any relation with them at all. They must be ostracized. They are a scourge and menace within and to our nation and people. I have in disgust separated myself from many I have known for between 10 and 40 years because they revile me. They are cowards and hateful and more than likely suitably marginalized by me. I detest them. As for the others, I suppose that they have had their last opportunities to redeem themselves if that is possible. In this I refer to millions. I am a social human being. I love people. I will not be a recluse. I am too mature theologically and politically and socially for that ever to happen. The only bitterness that I harbour is that the beauty of my life prior to mid 2000 has been destroyed. Their disadvantage is that the authentic identity that I am cannot change. I am a beautiful person, nurtured to be beautiful. That will always be. It is only that this time I cannot laugh at the ludicrousness of hatred endemic within our State as I did in Apartheid with its indiscriminate hatred in insider and outsider violence. I do however continue to laugh, but given the fact that this hatred has been directed directly at me, the personal nature of the attack defines that I now laugh as their hatred is thwarted and that they become increasingly burdened with the dreadful reality that they must contrive for a lifetime ahead to conceal their loss of freedom to be arrogant and blatantly destructive as they intended. None of this is adequate. I want to see to it that the Constitution meets its responsibilities in that they would be incarcerated for life.
