#### 1.2 Gender Mainstreaming

The challenge for the OSW has been that no one with authority within the administration has taken authority for driving the implementation of gender mainstreaming, however the following activities took place;

- development of the draft National Gender Programme of Action on Women's Empowerment and Gender Equality 2005-
- Developing a training manual for Public Sector managers, on gender mainstreaming.
- Participation in the review of the 'Education ¹¹²/for All, Goal 5'

- Report of the National Delegation to the 49th Session of the United Nations Commission on the Status of Women (UN CSW)


