- (ii) In ensuring that municipalities are able to pay their debts, the department is providing support to all municipalities on the implementation of the Revenue Enhancement Strategies that will enable them to collect what is due to them. Efforts are also taken to ensure that money is recovered from businesses, government departments and households that are not indigent. Provinces are to establish a Government debt forum to deal with government debt. Establishment of a national debt management working to deal with outstanding municipal debt and SALGA to develop a generic by-laws for municipal debt.
